Accountancy Services

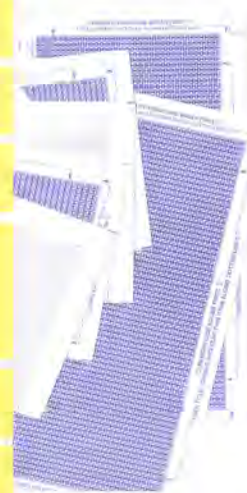

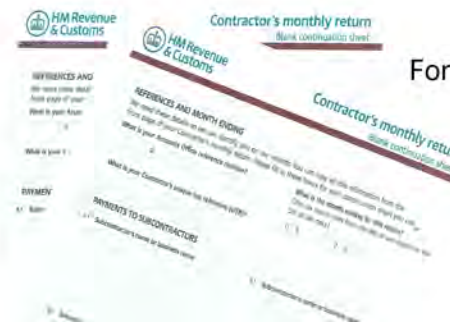
